

SA HOME LOANS PRIVACY STATEMENT

SA Home Loans is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the SA Home Loans Web site and governs data collection and usage. By using the SA Home Loans website, you consent to the data practices described in this statement.

Collection of your Personal Information

SA Home Loans collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. SA Home Loans also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by SA Home Loans. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. Use of Cookies

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize SA Home Loans pages, or register with SA Home Loans site or services, a cookie helps SA Home Loans to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same SA Home Loans Web site, the information you previously provided can be retrieved, so you can easily use the SA Home Loans features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer.
